Nominee: Alex Vassar

District: Arcade Creek Recreation & Park District

District Submission:

I am nominating Alex Vassar, Board Chair for the Arcade Creek Recreation and Park District, for the CARPD Outstanding Board Member.

Alex Vassar has served on the board of the Arcade Creek Recreation and Park District for five and a half years. His service to the district has included a year and a half as Board Chair (2021-Present), three years as Vice Chair (2018-2020) and six months as Interim General Manager (2021).

During his time as Vice Chair, Director Vassar led a working group which reviewed and updated the district's policies for the first time in a decade.

Alex also served three years on the Board's Finance Committee, setting funding priorities and ensuring sound fiscal policy through the thoughtful construction of a \$900,000 annual budget. Most notably, Alex spent months investigating the district's finances which revealed a previously unrecognized \$500,000 in outstanding debt owed to CalPERS for unpaid retirement benefits for former district employees. Recognizing that the amount owed was growing quickly, Director Vassar successfully led the board to adopt several significantly trimmed budgets, redirecting the funding to pay down the district's longstanding unfunded liability.

As a result, following our most recent annual audit, the auditor said that district was on its strongest financial footing in the decade that he had been conducting our reviews.

Finally, in from March to August 2021 Alex served as the district's interim General Manager. In that capacity, he led the creation of a secure centralized records storage, developed new policies for internal controls which have resulted in better oversight on district finances, oversaw the purchase of a new lawn tractor, gator and added work safety features in the maintenance shed.

Nominee: Ayn Wieskamp

District: East Bay Regional Park District



District Submission:

Director Ayn Wieskamp has served on the Board of Directors of the East Bay Regional Park District (EBRPD) for 23 years. EBRPD is a system of beautiful parks in Alameda and Contra Costa counties in California, serving over 2.8 million people. We preserve and protect 125,000 acres in 73 parks, including 1,250 miles of trails.

Prior to her being elected to the EBRPD Board, Director Wieskamp served as a Councilmember for the City of Livermore for 18 years. She had also served as a Director of the Livermore Area Recreation and Park District (LARPD) and the Alameda County Recycling Board. Director Wieskamp received the 1998 California Association of Recreation and Park Districts Special Award for her development of special family events and for her efforts to expand parks and trails to be closer to the underserved communities in her ward. The EBRPD Parks in her ward include some of the most highly visited parks in the county: Ardenwood Historic Farm, Mission Peak, Coyote Hills, Del Valle, Monument Peak, Sunol Wilderness, Pleasanton Ridge, Shadow Cliffs, Ohlone Wilderness, and Tassajara Creek. The cities within her ward in Alameda county include Brightside, Dublin, part of Fremont, Livermore, Newark, Pleasanton, Scott's Corner, and Sunol.

Director Wieskamp's unwavering advocacy for the preservation of the natural environment and providing access for all has made a lasting impact on the county and the community. Among her major achievements:

- As a member of the Alameda County Recycling Board, Director Wieskamp supported the creation of official recycling efforts in Livermore. Thousands of tons of waste have hence been diverted from landfills. Livermore and Berkeley were trailblazers in environmental conservation in the county.
- As an EBRPD board member, Director Wieskamp advocated for 20 years for the creation of a park at Dumbarton Quarry in Fremont. A shoreline campground was finally built on a quarry pit that was once 350 feet below sea level and required six million cubic yards of dirt to be filled from several large Bay Area construction projects. The Dumbarton Quarry Campground provides a convenient and affordable getaway for the communities in Alameda and Contra Costa counties during the pandemic. It is linked to thousands of acres of parkland with extensive miles of trails for hiking and biking.
- Director Wieskamp supported the protection of thousands of acres of land in the densely-populated Tri-Valley area, including additions to Pleasanton Ridge and Vargas Plateau Regional Parks in Fremont.
- As a local leader, Director Wieskamp has had to strike a fine balance between the public's needs and the challenges of serving as an equitable and inclusive leader -- sifting through complex and, sometimes, controversial/political issues to make sound and sustainable decisions for the community and the agency. Carefully managing limited resources and meeting public needs and expectations are key considerations in her decision making.
- Director Wieskamp is also a forerunner of several environmentally sound planning. She was a founding member of the Wheels Bus, Livermore Amador Valley Transportation Authority. Her community advocacy included memberships in League of Women Voters, Tri-Valley Conservancy, Tri-Valley Elected Women, Tri-City Ecology, Save Mount Diablo, and American Association of University Women.

Director Wieskamp is truly a champion ahead of her times and a dedicated public servant who has devoted her life to preserving parks for perpetuity and access for all.

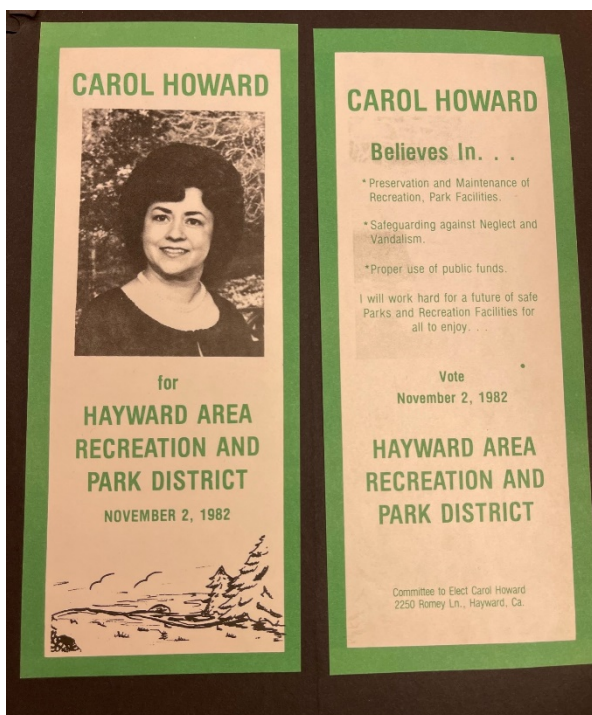

Board of Directors since 1982 and has made contributions and impacts that have significantly launched the agency into the future. As a member of the Board of Directors and Current President of the board, Carol serves for the District that provides recreation and park services to the residents of Ashland, Castro Valley, Cherryland, Fairview, Hayward, San Lorenzo and a section of the unincorporated area of San Leandro, California and represents services to over 309,000 residents.

Growing up in Hayward she attended Bret Hart School, the home of Harry Rowell's first 'Cowboy Show,' and graduated from Hayward High. Mrs. Pereira began her working for Machado's Hillside Chapel at the front desk/book work from 1991 to 2006. When Diocese of Oakland bought the business. Mrs. Pereira continued to work there until they purchased Sorenson's Brother Mortuary for an additional three years at the front desk/book work and retired in 2011, for a total of 20 years.

Now retired, Mrs. Pereira has been on the Hayward Area Recreation Park District since 1982 holding office for President for several times. This position allowed Mrs. Pereira to do what she loves making it possible for the community to enjoy all the facets and activities that are the diversity of the Hayward Area.

Mrs. Pereira is married to Leroy Pereira and has 5 grown children. She is a grandmother to ten children and a great-grandmother to sixteen and counting. She is active in Questers, an organization dedicated to the study, conservation and preservation of historical objects and existing landmarks for the benefit of today and tomorrow. As well as a member of the Hayward Area Historical Society, and dedicated supporter of the Rowell Ranch Rodeo.

Mrs. Pereira has served the community for 40 years. Because of her time served, she brings a wealth of historical knowledge to HARD. During her tenure on the Board, she has been a part of many facilities and park designs and opening. She has led the way for the District and its highest priority and mission of ensuring all residents have access to services and parks. She, along with the Board and Staff, were instrumental in the development and passing of measure F1 in 2016, a 250-million-dollar bond measure to acquire parkland in park poor areas and renovate and develop new parks and facilities. This ballot measure was such a priority for Mrs. Pereira that she personally worked hours making calls, walking neighborhoods, and answering questions to educate the public. Passing the ballot measure was an unprecedented achievement for the District. In the past two years, H.A.R.D. parks and facilities have grown exponentially, including the Mia's Dream Come True all ability playground and renovation of the largest regional park in the HARD system, Kennedy Park.

Mrs. Pereira has always had a love for Hayward Area Recreation and Park District and its rich history. She is collaborative and a historian, but her greatest achievement is her willingness to embrace and work tirelessly for the community she serves for forty years! It is with great pleasure that I nominate Mrs. Carol A. Pereira as Outstanding Board Member for CARPD.
